Bridge at Brodie: Should have railing completed soon but no date established - workers pulled off to work on areas impacted by flood.

Gravel has not been removed from the Counties resurfacing efforts in the Gatling Gun area - Pam Baggett to inquire.

Talked to constable about gravel haulers and large trucks illegally using Brodie Lane as a thoroughfare, they will be out looking for them.

New Business

Ron Stried Annexation presentation:

Entered into Strategic Partner Agreement with the City of Austin for full annexation on Dec. 15, 2020

COA will not acquire parks or other SHHOA property

Constable cost approximately \$120,000 year and was not a part of the SPA as we will receive our police services from COA

An original agreement between the MUD and the COA struck years ago stated that Shady Hollow could be annexed within three years of the year 2000. We were fortunate to be able to delay until the year 2020

The COA will provide the following services: police, fire, EMS, solid waste, streets transportation and drainage. The COA will have future meetings with the HOA about these services in greater detail

Pam Baggett requested the SPA be posted on our website

Pam Baggett would like to inform non-MUD sections of the situation regarding proposed annexation. The reason behind this is that these sections are not included in the SPA, but could be annexed in 2020 as well

Set up meeting to inform residents about process and challenges

Mike Cain and Aaron Vollmer suggest we gather more information prior to said meeting

Pam Baggett suggested we set a date so it does not get lost in the shuffle. Mike Cain suggested we set a date for the meeting no longer than 60 days from today.

Fire station discussion:

The MUD owns the fire station. Currently the bond is being paid down by the \$50,000 a month rent that MVFD and AFD are splitting. AFD will take over the full cost of the monthly rental when it takes full possession of the station.

COA will take over all MUD assets except for the house that currently holds their office space

June 12 2016 COA takes over fire station, ESD will be back up on all calls

The MUD Board held its regular monthly meeting on January 5, 2016 at the MUD Office Building, 3910 Capistrano Trail. All directors were present.

Deputy Agiewich presented the monthly Constable's report. He reported December had generally been a quiet month, but noted there had been a fatal collision between a vehicle and a bicyclist on Brodie Lane.

Mr. Haag updated the Board on the requirements of two pieces of legislation enacted during the last legislative session. HB 1295 (Gov't Code §2252.908) requires certain business entities doing business with the District to file a disclosure document with the Texas Ethics Commission – the disclosure requirement applies to contracts with a value of at least \$1 million. SB 1812 requires any entity (such as the MUD) with eminent domain power to annually report specific information to the Comptroller for posting on an online eminent domain database.

Mr. Haag reported his office had been contacted by the Austin Fire Department regarding AFD's agreement with ESD#5 that AFD take over the operation of the Brodie Lane fire station. AFD provided the MUD with notice that it intends to jointly occupy and locate AFD staff and equipment at the fire station beginning June 12. 2016. If the ESD decides to voluntarily vacate the station on/after that date, AFD will become the first responder for Shady Hollow and will assume the ESD's responsibilities regarding the fire station lease, including the payment of rent to the MUD.



The Constable's report for January included the following:

- worst of the speeders: 49/30 (Onion Hollow Run, Green Emerald, Lost Oasis), 45/30 (Silmarillion):
- ▶ citations/warnings: speeding (Capistrano, Spotted Horse, Saddle Mtn, Hobbiton, Silmarillion, Green Emerald, Lost Oasis); no driver's license (Green Emerald); no brake light (Treadsoft);
- ▶ community contact spoke with individual residents regarding community concerns (on-going); met with resident regarding illegally parked vehicle (Cotulla);
- ▶ assist TCSO: home burglary-several items stolen (Silmarillion); loose dog-escaped from yard (Lost Oasis, Knipp Cv); house with open back door-checked ok (Gatling Gun); family disturbance (Brodie/Capistrano); someone in vehicle hid package containing drug paraphernalia in shrub near the street (Eldorado); reckless driving (Brodie).

Rock the Proxy: It's Your Voice

We've got an election coming up, and even if you're unable to attend the membership meeting and election, you can still vote by proxy.

A proxy is the written authorization that allows one person to appoint another (the proxy holder) to vote on his or her behalf. State law and the association's governing documents specify that the association can use proxy voting.

Why would you use a proxy? Maybe you're traveling during the election or have other obligations that prevent you from attending the meeting, but you still want your voice to be heard.

If you're interested in using a proxy, there is one included in your election packet. Cite the name and address of the individual you're appointing to cast your vote. Then list your name, address and telephone number, and sign and date the form.

The association can only accept one proxy form per person, so be sure to fill out your form accurately. By only accepting one official form, the association doesn't need to check each proxy to determine if it's legally sufficient. It also eliminates any potential problems if the vote is close.

Just be aware that by assigning your proxy to another person, you've authorized the proxy holder to vote for you as he or she sees fit. The proxy holder is responsible for voting or abstaining from a vote.

Essentially, a proxy is an act of trust—the proxy giver must trust the judgment of the proxy holder. The proxy giver may think the proxy holder will vote for a certain candidate or issue, but the proxy holder isn't legally bound by that assumption unless it's written on the proxy form.


