Shady Hollow MUD Meeting Minutes

The MUD Board held its regular monthly meeting on May 4, 2021 in person at 3303 Doe Run and a special meeting on May 10, 2021 via tele/video conference.

REGULAR MEETING:

As Deputy Ken Run was unable to attend the meeting, Director Stried presented the Constable's report – no significant issues during the past month.

Mr. Evans reported that the District's Rate Order was complete and would be finalized and posted on the District's website in the near future. Ms. McCalla noted she had received all required certifications of completion for the required cybersecurity training course.

The Board approved a contract with NewGen Strategies and Solutions, in an amount not to exceed \$7,000, which would allow New Gen to work with the District on an "as needed" basis to assist in strategic and financial management of the District's water and wastewater services.

Director Stried reviewed the District's 2021 Preliminary Estimate of Value Information from TCAD and noted the estimate reflected a taxable value of \$446,840,375.00, an increase over last year's taxable values. Director Stried also provided the Website Report and reviewed the analytics included in the Board Packet.

Mr. Swanks reported repairs had been made to the District's lift stations. He stated his office was investigating software options for a supervisory control and data acquisition (SCADA) system for the District.

SPECIAL MEETING:

The Board approved the Order canvassing the returns of the May 1, 2021 maintenance and operation tax election after receiving the official certified results from the Travis County Elections Administrator.

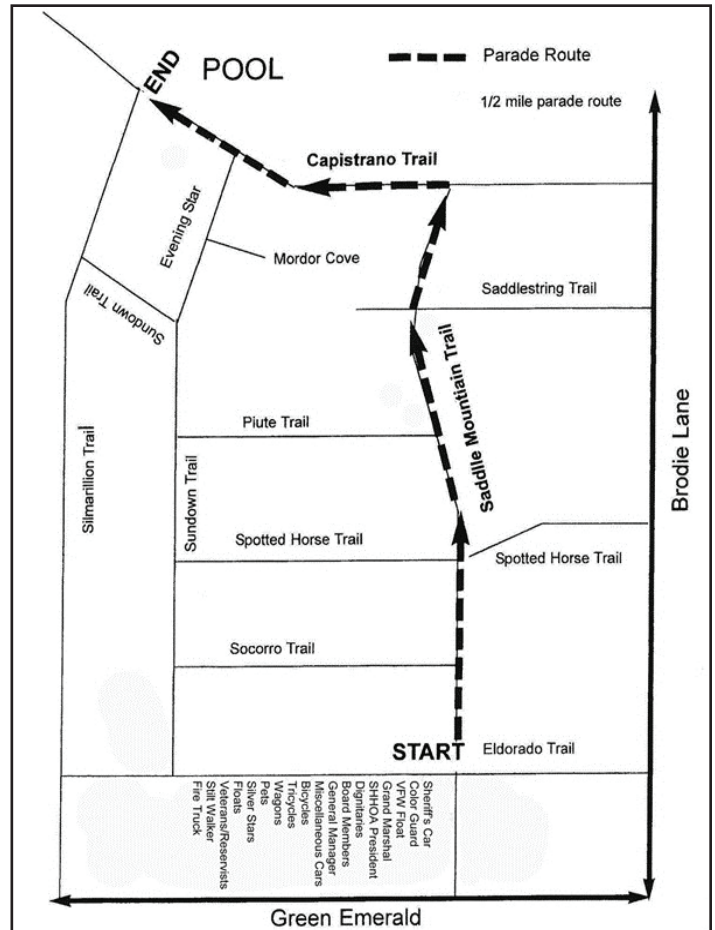

Citizen Communication

Kristen Templeton: Jazzercise instructor who would like to hold classes at the community center. Cathy Grayless would like to sponsor the class. Jazzercise carries their own insurance policy, and they pay royalties for the music that is used in class. Handout for discussion given to board members.

Jim Downing: PowerPoint presentation regarding the eight dead trees at the Community Center and Capistrano Park. Jim suggested finding reliable tree suppliers and maintenance companies. He would like the board to consider negotiating a discount with companies to take care of our trees and we would give free advertising in our newsletter in exchange.

Allan Barr: Expressed concern regarding the Architectural Control Committees being undermined.

Jasen and Brandi Wallace: Moving into the neighborhood and wanted to introduce themselves.

Shady Hollow MUD Report – Dr. Ron Stried

- Dr. Stried announced his resignation from the Shady Hollow MUD Board effective June 2021.

- Handed out a timeline of events for the MUD Board.

- The Shady Hollow MUD spent down the money they had to help with the rates for the citizens of the neighborhood. Since the water and wastewater has been returned to the MUD from the City of Austin, the MUD is obligated to run the business. They will need to charge rates that will sustain it. The rates are roughly \$11 for one thousand gallons after ten thousand. The City of Austin's rate is \$29. The rates for the MUD will be this as long as they need to be and will probably be reevaluated in August.

General Managers Report – Amy Loughrey

Administration

The HOA office remains closed to visitors, but are still assisting the community via email, phone, and by appointment for HOA services. We are working with the community center chair to determine an update regarding reopening the office.

- Thank you to the community for paying their dues. We have a 1% outstanding collection rate.

- We are at an escalated all-time high for home sales price. 24 qty. homes sales year to date.

- 110 architectural applications year to date – a record number for Shady Hollow.

- We will be having a Section 6 Architectural Control Committee Election. Information will be in the June 1st newsletter. There are six approved candidates.

- The HOA issued 30 covenant violation notices during April 2021. Trash cans visible in front of the home is the #1 violation.

Parks and Common Areas

GATLING GUN:

- Actively seeking and working with vendors for proposals on the landscaping work to complete this park. We have 3 large ash trees that appear to have died in the freeze. We will wait until later in the season to see if they have any signs of regrowth.

CAPISTRANO:

- Estimates have been received to replace landscaping for this park. We hope to have the park area completed before the Fourth of July festivities.

DOE RUN:

- The replacement of dead bushes has taken place along with removal of two dead trees. Both trees were young and recently planted in the past two years. We also removed a trailer of dead brush from broken and removed tree limbs.

SH WEST:

- Received a report that we may have an additional tree to be removed in this park. We will monitor at this time. The dog park has been a great success. We have received numerous calls thanking the board and HOA along with telling us how much they enjoy the new amenity. We have been working with vendors regarding a long-term ground cover maintenance plan. There have been no reports of issues with the dog park thus far.

CAPISTRANO POOL:

- The pool is experiencing a leak and we have closed adult swim until discovery is completed on May 17th by Austin Leak Detection. We determined the rate of water loss was significant enough that continuous refilling of lost water would be at too large of a financial detriment for the community. We have received very few inquiries about the closure - for the most part the community is understanding. We are hopeful to have the leak sourced and repaired prior to the scheduled opening date for General Swim of May 25th.

- Lifeguard orientation for most of the lifeguards was completed on May 8th. The lifeguard staff received a thorough first aid and rescue training from Premier Recreation. The staff commented it was the best training. Our new Lifeguard Supervisor, Drew Cain, is doing a good job keeping up communication and getting them ready for the upcoming season.

SPECIAL EVENTS:

- Easter Eggstravaganza - Event budget was \$2,500 - Expenditures totaled \$2,499.01...way to go Jamie and we have items leftover to utilize next year.

- Fourth of July - Preparations are underway. The Precinct 3 County Commissioner and her Chief of Staff are honored to accept the role of Grand Marshals for our event. Anyone who would like to nominate someone for the Parade Marshal, please contact the Events Chair, Jamie Rygg.

Our register balance in our Chase Bank operating account as of 4/30/21 was \$475,081.71. The balance was reconciled to the QuickBooks ledger by both the Treasurer and the Heyman CPA firm. Our reserve accounts as of 4/30/21 held \$143,809.97 in our Chase Reserve Account and \$211,175.67 in our CD at TDECU. Our total reserve accounts at 4/30/21 aggregate to \$354,985.64. We transferred \$8,216.67 from our operating account to our reserve account at Chase Bank in accordance with the funding plan detailed in our Jan 2021 reserve study.

Revenue

On a Cash Basis presentation, Line #total revenue for the month ending 4/30/21 was \$15,326.34 versus budgeted revenue of \$30,100. Assessment revenue for April were less than budgeted because of better-than-expected assessment collections during the previous 2 months. Once again, facility fees were significantly up for the month of April. \$1,625 versus budget revenue of \$100. Clearly this reflects the change in vaccination rates and infection rates for the SARS COV-2 virus. It appears that a sense of normalcy is returning to our community as restrictions have eased. Overall, net loss for April aggregated to -\$23,279.52 versus a projected net loss of versus projected loss of -\$13,471.82. This is directly related to the lower than budgeted assessment revenue for the period. Note that we had total expenses.

Expenses

Our legal expense for the month of April was \$4,337.50 which exceeded the budgeted amount of \$2,500.00. It should be noted that water expenses are now being handled by the Shady Hollow Mud, and as we expected, we are now paying according to the MUD negotiated rates (which are significantly better than what the City of Austin would have charged us). You should expect to see an ongoing significant variance from the budgeted projections since we had no way of knowing what our final rates might be. In addition, everyone should expect Electricity costs for all our facilities to return to pre pandemic levels.

MRI Expenditures

There were no expenditures for MRI expenditures for the month of May.

Committee Report

1. Executive, Joan Allen – Did not officially meet.
2. Finance, Geoff Lawson – Did not meet.
3. Recreation, Laura Kennedy – Met with the Pool Committee on May 5, 2021. Met at the Capistrano Park. They received three bids to replace and remove dead shrubs. The budget is \$2,500, two bids came in at \$2,500, and the third was a no bid. Greener Pastures is the company selected. Insurance agent noticed stumps are a tripping hazard in the area. It will cost \$1,900 for stump removal. Next meeting will be held at a different park location.
4. Pool, Sunil Shenoy – Met with Parks and Recreation Committee on May 5, 2021. A couple days later they found the pool leak and decided to close the pool for adult swim. Food dye was used to check all the skimmers. Mr. Casarez swam down to the bottom of the pool and placed a bag over the drains to see if any water was leaking despite pump being turned off. Leak company was able to locate the leak and repair it. Company recommends keeping an eye on other pipes. Repairs and detection cost approximately \$4000. Two leaks were found by the skimmer in the wading pool. Swim leak tryouts should be scheduled for Sunday. Pool will be opening and restricted to 75 people as of right now. Sunil recommends keeping pool numbers limited to not ramp up covid numbers. CDC recommends keeping distance from those not in your family. Jim Downing gave a PowerPoint presentation of leak detection and repair.
5. Community Center, Russell Downey – Did not meet.
6. Welcome, Mary Ellen Mathis – Did not meet. Hoping to start making visits soon. Meeting to be announced.
7. Policy, Russell Downey – Did not meet.
8. Architectural Control, Jason Zirkle – Did not meet and nothing to report.
9. Traffic, Clay Zelisko – Did not meet. We should receive the new speed detection boxes next week. The radar control speed limit signs should be received and installed mid to late June. We will likely put the radar signs on Sesbania first followed by Capistrano, Reynosa, and Silmarillion Trail. The goal is to order two more radar signs in the near future. We are looking into dropping the speed limit on some streets. General Manager, Amy Loughrey commended Clay for all of his hard work that he has put into this endeavor.
10. Events Committee, Jamie Rygg – Did not officially meet. Discussed the Fourth of July Festivities. We will have a 5k run, pool games, Tru BBQ food truck and Kona Ice as well as our traditional parade.
11. Long Range Planning, Jim Downing – Pushed discussion to new business.

NEW BUSINESS

- Discuss and take action regarding request for use of community center for Jazzercise class.

- Joan Allen recused herself from any items regarding this discussion.
- The class would meet 14 times a week. Morning, afternoon, and evening times would be available.
- Classes are 45 minutes in duration.
- Board discussed that the class would need to be predominantly residents.
- MOTION to enable Jazzercise and the HOA to engage in a business relationship subject to 1. we can prioritize our events over their classes, 2. there is a resident sponsor, 3. the HOA will be paid \$500 per month with a 90-day trial period, and 4. the HOA General Manager has authority to resolve conflicts by Jim Downing, seconded by Clay Zelisko. 8 yay (Russell Downey, Geoff Lawson, Jim Bateman, Jamie Rygg, Jim Downing, Sunil Shenoy, Clay Zelisko, Jason Zirkle), 2 nay (Laura Kennedy and Mary Ellen Mathis), 1 recused (Joan Allen)

-Discuss and consider action regarding request for use of community center for Knights of Columbus

- Knights of Columbus are asking to meet on the 2nd Monday of each month.
- Board previously approved the use of the facility for St. Catherine's while they were redoing their activity building in the church.
- Church is limiting the group to a certain number of participants currently due to Covid. Resident is asking to sponsor the event and hold the meetings.
- MOTION to enable this group to hold their meetings here subject to them paying the normal fees for the normal period of time contingent upon a resident being present during the meetings by Jim Downing, seconded by Geoff Lawson. Unanimous approval.

-Discuss and take action regarding pool leak

- Nothing more to add from the committee report. Sunil will do more research and report back to the board. No MOTIONS made.

-Discuss and take action regarding updates and survey of the Capistrano Park and Pool area

- Last meeting, we discussed the history of the wading pool and the roadblocks we encountered. All are in the City of Austin critical water transition zones and mostly within the 500-year flood plain.
- Jim Downing gave a PowerPoint presentation to explain the benefits of filing a Vested Rights Petition and Site Plan Exemption application with the city.
