Outdoor Water Conservation Tips

Even though we use water every day, it's easy to take it for granted. Just imagine how you would function without clean water. It's everyone's responsibility to conserve and protect water resources. The decisions and actions you make today truly affect our water resources for the future. The following suggestions will help you get in the habit of saving water in the great outdoors:

- Get a rain gauge to measure rainfall. One inch of rain per week is generally sufficient for lawns and gardens. Supplement only when rainfall is inadequate.
- Use mulch around landscape plantings.
 Mulch will help eliminate weeds and hold moisture in the soil.
- Select hardy plants that don't need much water. Native plants that are well adapted to your climate and soils will survive well without supplemental watering.
- Water during the cool part of the day to avoid rapid evaporation.
- Raise the mowing heights on your lawn mower. This promotes healthier grass that can better survive dry periods.
- When watering is necessary, water slowly and thoroughly. If you notice puddles or runoff, turn water

- off and wait for water to soak in Also be sure your sprinkler puts water where you need it—not on driveways or sidewalks.
- Wash cars efficiently. First give the car a quick rinse, and then turn the water off. Wash one section of the car at a time and rinse that section quickly. Turn the water off each time.



The MUD Board held its regular monthly meeting on April 4, 2016 at the MUD Office Building, 3910 Capistrano Trail. All directors were present.

Deputy Agiewich reported there had been several vehicles burglarized throughout the District, and he emphasized that vehicles should be kept locked at all times. He said he had followed up on a call about a vehicle on Capistrano with expired license plates, and he would contact the owner of the vehicle to have the owner update the car's registration or move the vehicle. Deputy Agiewich informed the Board that he was retiring from the Constable's Office as of April 7. He stated that the Constable's Office would provide a replacement deputy or deputies, but that no one had been selected to date. He said he had enjoyed working with the residents of the District. The Board expressed their appreciation of Deputy Agiewich's service to the District and wished him well in all his future endeavors.

The Board approved an update to its Ethics Policy to account for recent legislative changes.

The Board next reviewed a draft Delegation Policy, which had been revised to include the provisions requested by the Board at the March 1, 2016, meeting. Ms. Johnson (the District's attorney) explained that the purpose of the Delegation Policy was to institute adequate controls for the safekeeping of the District's funds while allowing for the timely payment of bills and conduct of District business by the District's General Manager. Ms. Wheeler (the District's General Manager) told the Board that she had reviewed the Delegation Policy and that it was her belief that the policy encompassed all her current responsibilities. After discussion, the Board approved the Delegation Policy as presented.

Ms. Johnson then updated the Board on the status of the Austin Fire Department's intent to occupy the Brodie Lane fire station. She recalled that the AFD had sent a letter notifying the District of the AFD's intent to occupy and locate AFD staff and equipment at the District's Fire Station beginning on June 12, 2016. Ms. Johnson stated her understanding that the AFD was working with the Emergency Services District No. 5 (the "ESD") to prepare an addendum to the lease between the District and the ESD. Ms. Wheeler noted that the AFD was delinquent in its payment to the District for its lease payment for use of the fire station. Ms. Johnson stated that her office would contact the AFD regarding the delinquent payment.

In response to concerns from a District resident regarding the possibility of wildfire in the SHW nature preserve, the Board agreed that Environmental Survey Consulting ("ESC"), which provides ecological preserve management services for the District, should be contacted regarding an assessment and possible reprioritization of its scheduled work for fire suppression efforts and wildfire brush management.

Ms. Wheeler reported that two of the three replacement manholes on El Dorado had been installed and that the third was in the process of completion. She also noted that three fire hydrants in the District would be repaired and/or replaced.

Next, Ms. Johnson discussed with the Board the District's request that the City consider rolling back its wholesale water and sewer rates to the District to the rates that the Public Utility Commission (the "PUC") has determined are fair and equitable and to refund the District for the overcharges the District has paid since the City enacted its 2012 Rate Ordinance. She reminded the Board that the City had responded by generally denying the District's request, and she reviewed various options with the Board, including filing a water rate case against the City. President Stried noted that a coalition of municipal utility districts would likely be more effective than action from a single district, and the Board concurred. After further discussion, Ms. Johnson told the Board she should have additional information at the May meeting.

Why We Have a Design Review Process (ACC)

Like many community associations, we have a set of written design review standards and processes. Some homeowners mistakenly believe these standards restrict their freedom of individual expression; actually they provide a framework within which each homeowner can express individual tastes and preferences. The standards have been carefully developed to reflect a balance between individual rights and the good of the entire association—that is, property values.

OK, but why are do we need processes and guidelines to maintain architectural standards?

Perhaps most important, we need a basis for treating all homeowners fairly and reasonably. Written guidelines allow you and the design review committee to work from the same criteria.

Sometimes architectural requirements can be complex. The guidelines show you exactly what is required, and helps you design improvements that comply with the community's standards.

And then there's the application and approval part of the process. The review committee members assure you they want the paper work to be as simple as possible for everyone. The guidelines take the guesswork out of your application and their decision making.

In fact, they not only provide criteria for the current committee to make appropriate decisions, but for successive committee members to make consistent decisions in the future. Without the criteria in the guidelines, the application approved today may result in construction deemed unacceptable by new committee members upon completion.

One last purpose of the guidelines is to clarify the association's authority in this area. State statutes and our governing documents give the association a legal right to enact and enforce design review standards. The guidelines spell this out so everyone understands they must comply even if they don't agree.
